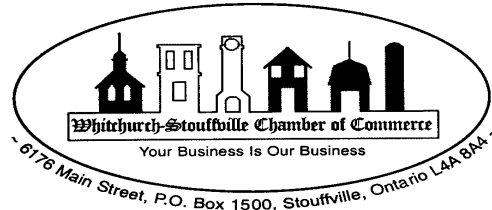

Funeral Prepayment before July 1st Saves the HST!

The new HST being introduced on July 1, 2010, will add 8% to the cost of a funeral, in addition to the 5% GST now applied. On the cost of an average funeral, this means \$500 to \$1,000 in additional cost.

However, the Government of Ontario has announced that if you prepay a funeral prior to July 1st (or enter into a time payment contract beginning before that date) you will avoid paying the new HST. In addition, you can save 20% on the service fee and casket by prepaying rather than waiting until the time of death to cover these expenses.
